## ABOUT SOUTH COUNTY HEALTH

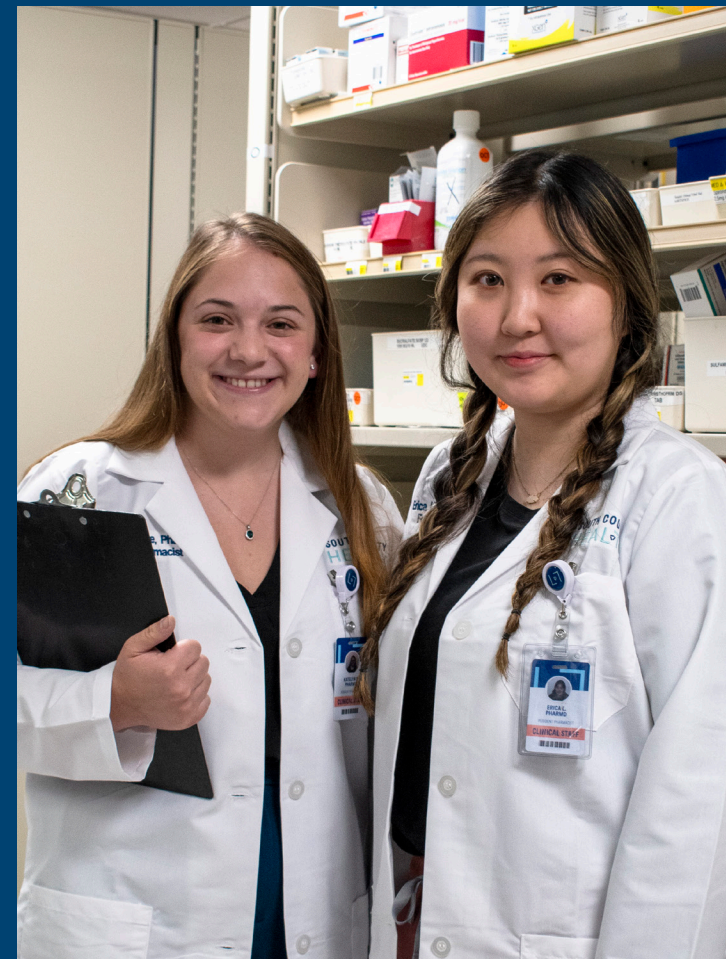
